
I would also like to take this time to recognize Andrea Betting for her commitment to adoption and for the work she does through her agency Florida Adoption Center to ensure all children have a family to love and nurture them.

I would like welcome Mr. Bill D'Aiuto, Central Regional Managing Director for the Department of Children and Families. He will be speaking on DCF's strategic priorities, legislative priorities and his perspective on the state wide increase in out of home care over the past few years.

The month began with deployment of the BFP Disaster Preparedness Plan in preparation for Hurricane Matthew. Our staff, partners and providers did an exemplary job executing the plan and ensuring the safety and well-being of our children, youth and families. All children were accounted for, evacuation plans for group homes and foster families received and IL youth located and supported. DCF Central Regional Managing Director Bill D'Aiuto provided leadership and support pre and post hurricane. Thankfully BFP experienced minimal impact and our staff and providers homes and families were safe.

I am pleased to report that BFP received an \$80,000 bonus payment from the Child Welfare Integrated Health Services Partnership for successfully managing the utilization of behavioral and medical health services under the program.

We also received good news from the California Evidence Based Clearing House indicating the C.A.R.E.S. program application submission met criteria as a Level 3 program to be listed on the clearinghouse portal.



Specific criteria for each classification system category are presented below:

1. Well-Supported by Research Evidence

2. Supported by Research Evidence

3. Promising Research Evidence (C.A.R.E.S.)

- a. At least one study utilizing some form of control (e.g., untreated group, placebo group, matched wait list study) has established the practice's benefit over the control, or found it to be comparable to a practice rated a 1, 2, or 3 on this rating scale or superior to an appropriate comparison practice. The study has been reported in published, peer-reviewed literature.
- b. Outcome measures must be reliable and valid, and administered consistently and accurately across all subjects.
- c. If multiple outcome studies have been conducted, the overall weight of evidence supports the benefit of the practice.
- d. There is no case data suggesting a risk of harm that: a) was probably caused by the treatment and b) the harm was severe or frequent.
- e. There is no legal or empirical basis suggesting that, compared to its likely benefits, the practice constitutes a risk of harm to those receiving it.
- f. The practice has a book, manual, and/or other available writings that specify the components of the practice protocol and describe how to administer it.

We have 6 acts committed to include: Melissa Romero from Modus Operandi, Steven Audino From Harris Corporation, Teachers from Roy Allen Elementary, Brevard Community Foundation Executive Director and Board Chair, Madison Conradis and Cathy Bell from Logo By Geiger, and Eric Smith, his wife Amy, and Laurie Anna. The Judges for the evening include: Malak Hamad, Brooke Deratany Goldfarb, Rob Rains, and Nancy Peltonen.

What an amazing and fun event it is going to be. I am so grateful for all of the support members have offered to ensure the event is a successful and memorable occasion.
