- Page 7: Notes: Principles of consolidation
 The accompanying consolidated financial statements include the accounts of Community Based Care of Brevard, Inc.
 d/b/a Brevard Family Partnership and its financially interrelated affiliates, Brevard C.A.R.E.S., Inc., The National
 Center for Innovation and Excellence, Inc., Family Allies, Inc., and the Brevard Family Partnership
 Foundation, Inc. which are under common control. Intercompany transactions and balances have been eliminated in
 consolidation.
- Page 24: Internal control for financial reporting: The best report than can be achieved; there were no findings.
- Page 26: Compliance: The best report that can be achieved; there were no findings.
- Page 29: Federal Awards: The agency is now qualified as a low-risk auditee; there have been no finding for two years.
