**The following are the primary tasks of the FPOCF Governance Board Membership:**

- Act as the fiduciary and guardian of the organizational assets;
- Review and approve the annual Family Partnerships of Central Florida FOA budgets;
- Establish short and long-term goals;
- Assess progress toward goals;
- Assume stewardship responsibility for Family Partnerships of Central Florida FOA finances;
- Review and where applicable set policies for the overall governance of the agency, and
- Abide by the Carver's Policy Governance Model.

- Attend regularly scheduled board meetings in accordance with the company Bylaws.
- Participate on at least one board committee.
- Become informed about the policies and programs of Family Partnerships of Central Florida and the Family of Agencies.
