## **Board Report**

- COVID-19 The FOA's leadership team continues to meet weekly to discuss in detail our ongoing assessment and plans for our staff's return to the workplace. I will continue to monitor closely the guidance and actions provided by the Office of the Governor, the Department of Children and Families, the CDC and our local Courts. The number of incidents of positive COVID remains low throughout our workforce and children and families served. We are continuing to provide PPEs for both our agencies and the agencies that provide services and placements for our children in out of home care. Our "Return to the Office" work date continues to be suspended until further notice.
- DCF is providing COVID-19 testing kits to CBCs around the state upon receipt we will be administrating monthly such test triaging those at risk since the supply will be limited. The tests and training are being provided and paid for by the Department of Children and Families.
- We submitted to the DCF's Secretary our 3% 6% Reduction Plan for 2020 2021 and 2021 2022. Our efforts were to minimize any impact of services to our children and families. Although a difficult task, we are proud of our commitment to hold both our families and provider agencies harmless from this exercise. Thanks to our stewardship of the PPP funds, we will be able to avoid furloughing or eliminating any staff positions.
- Jim Carlson and I recently met with Senator Debbie Mayfield to update her on the on-going challenges with COVID-19 and the need for her support and advocacy around funding for child welfare in light of the economic impact of COVID both on the Federal and State levels. Senator Mayfield and I agreed to connect with incoming President of the Senate Wilton Simpson, an adopted child himself, to gain his support and awareness of the work we do to promote healthy adoptions of the children within our system of care.
- We are having ongoing meetings with "Open Table" a nationally recognized model for working with at-risk children and families and further linking this engagement with that of our efforts to collaborate with our faith community. This model and our commitment to community engagement ties in wonderfully with the conversation I had with our State's First Lady earlier this year. We both agreed that a more formal approach to connecting with local churches will better augment our system of care and further recognize the faith community as a partner.
- Our Brevard Virtual Summit was a huge success. We give much thanks to the participation of Representatives Spencer Roach and Patricia Williams, Attorney Candace Brower, Alan Abramowitz, the State Director of the GAL Program, Zachary Gibson, Chief Child Advocate with our Governor's Office. Kelly Swartz moderated, and I had the privilege to be a member of our Q & A panel. Julie Boynton and several others ensured the virtual event we transmitted far and wide with high professional quality.
- Creative Network Innovations is the new information technology (IT) vendor after our team's diligent review of several Request for Proposals (RFP). We wanted cutting edge technology, superior customer service, a cost-effective contract and finally a relationship predicated on working towards understanding the growing needs of our organization.
